Police Chief Update Memorandum

Officer Neil Taylor and Thomas White have resigned from the Department. Officer Brandon Sachse of Fort Atkinson P.D., Austin Schmidt of Jefferson P.D. and Justin Geske of Jefferson P.D. have been hired as part-time officers for Johnson Creek. In addition, Officer Gary Steinhorst and Officer Darrin Holcomb have completed rifle training for rifles placed in the squads. The department has completed the purchase of TASERS for service placement upon officer training. The State Speed Grant concluded at the end of September. Tobacco compliance checks ended in September. The department will be adding a new squad in 2016 subject to Village Board approval. Finally, the Village has seen a rise in domestic abuse cases including a domestic stabbing assault during the week of September 20th.

Fire Chief Update Memorandum

The fire department currently has 58 active personnel including a Public Information Officer (PIO), 33 firefighters, 11 EMTs, 3 AEMTs and 11 Paramedics.
